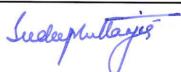

- 1. The above results have been reviewed by the Audit Committee and subsequently approved by the Board of Directors at their respective meetings held on 3rd July 2020.
- 2. Tea industry being seasonal in nature, results for the quarter (which includes profit / (loss) of the Tea Division) cannot be taken as indicative of results of the full year.

 3. Results for the last quarter are balancing figures between the audited results for the full financial year and published year to date figures upto third quarter.
- 4. Effective 1st April 2019, the company adopted Ind AS 116 *Leases*, and applied the same to all applicable lease contracts existing on 1st April 2019 using the modified retrospective cumulative method allowed under the standard. Linder this method, the cumulative adjustment, on the date of initial application, is taken to retained earnings and accordingly, comparatives for the year ended 31st March 2019 have not been retrospectively adjusted. On transition, the adoption of the new standard, in the accounts, resulted in recognition of a Right-of-Use Asset (ROU) of ₹ 364.78 Lakhs and a Lease Liability of ₹ 414.42Lakhs, the difference being a cumulative debit to retained earnings of ₹ 35.82 Lakhs(Net of Taxes). In the Statement of Profit & Loss for the current period, the nature of expense for operating leases has changed from lease rent in the previous year to depreciation cost for the ROU assets and finance cost for interest accrued on lease liabilities. The net effect of this adoption is that the profit before tax for the period is lower by ₹ 13.13Lakhs.
- 5. Due to outbreak of COVID-19 globally and in India, the Company's management has made initial assessment of likely adverse impact on business and financial risks, and believes that the impact is likely to be short to medium term in nature. The management does not see any long term risks in the Company's ability to continue as a going concern and meeting its liabilities as and when they fall due.
