I, Atul Kumar Labh, Practising Company Secretary (FCS – 4848 / CP - 3238) and proprietor of M/s. A. K. I submit my report as under :

1. The remote e-voting period remained open from 09:00 A.M. IST on Tuesday, the 7<sup>th</sup> day of September, 2021 up to 5:00 P.M. IST on Thursday, the 9<sup>th</sup> day of September, 2021.
2. The shareholders holding shares as on the “cut off” date, i.e. the 3<sup>rd</sup> day of September, 2021 were entitled to vote on the proposed 2 (Two) resolutions as mentioned in the Notice of the AGM dated the 24<sup>th</sup> day of June, 2021.
3. The Company had also provided e-voting facility at the AGM to enable the shareholders attending the AGM through VC / OAVM to cast the votes in case the same had not been cast by them through remote e-voting.
4. The votes were unblocked on Friday, the 10<sup>th</sup> day of September, 2021 around 12:30 P.M. after the completion of the AGM in the presence of two witnesses, namely, Mr. Narayan Chandra Saha, residing at 108, Sarat Chatterjee Road, Howrah – 711102 and Mrs. Anushree Dasgupta, residing at 28/N, Dwijen Mukherjee Road, Behala, Kolkata – 700060, who are not in employment of the Company.
5. The e-voting data/results downloaded from the e-voting system of CDSL were scrutinized and reviewed, the votes were counted, and the results were prepared.


